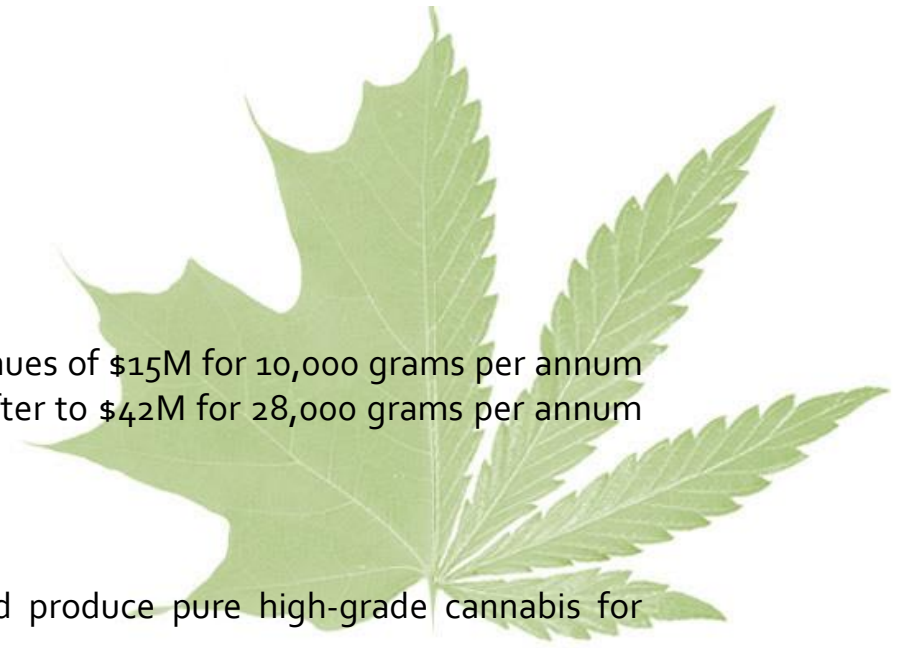

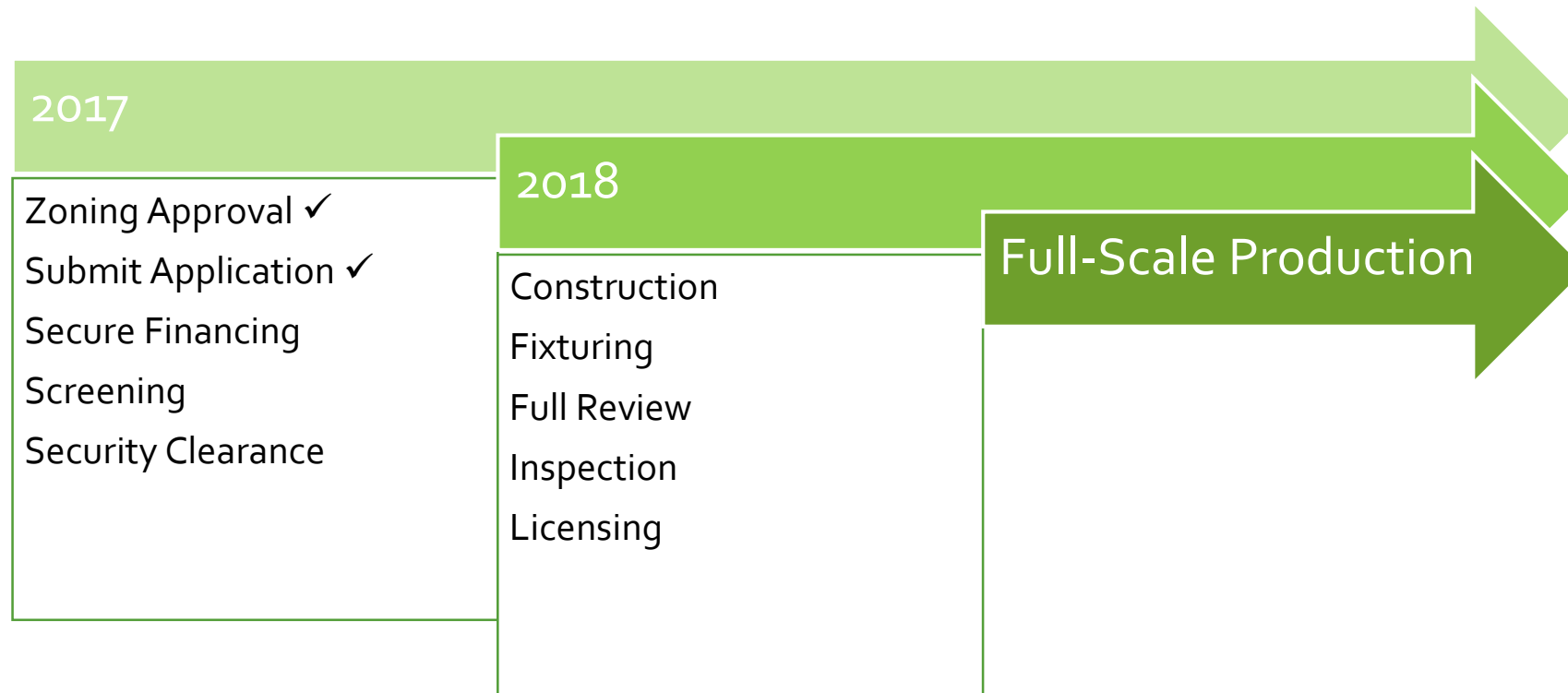

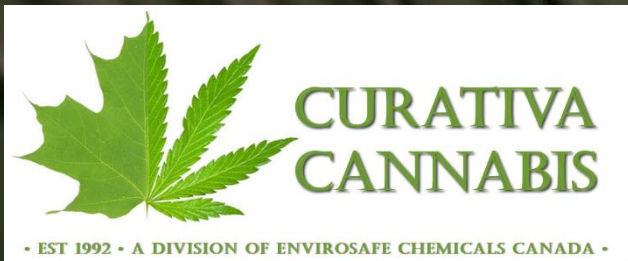
Business Strategy

The Cannabis Industry

- Canada is a leader – legislative, political environments are more favourable towards medical cannabis globally.
- 202K medical marijuana cardholder patients currently registered in Canada and growing at 10% month-by-month, estimated to grow to 360K by 2019.
- Recreational legislation forecast by July 2018 is estimated to grow a consumer base to 2 million people with revenues estimated approximately \$9.0B by 2020.
- Medicinal consumers range in age from small children to elderly persons providing them with health benefits that treat a variety of disorders.

- A strong need for alternatives for pain management.



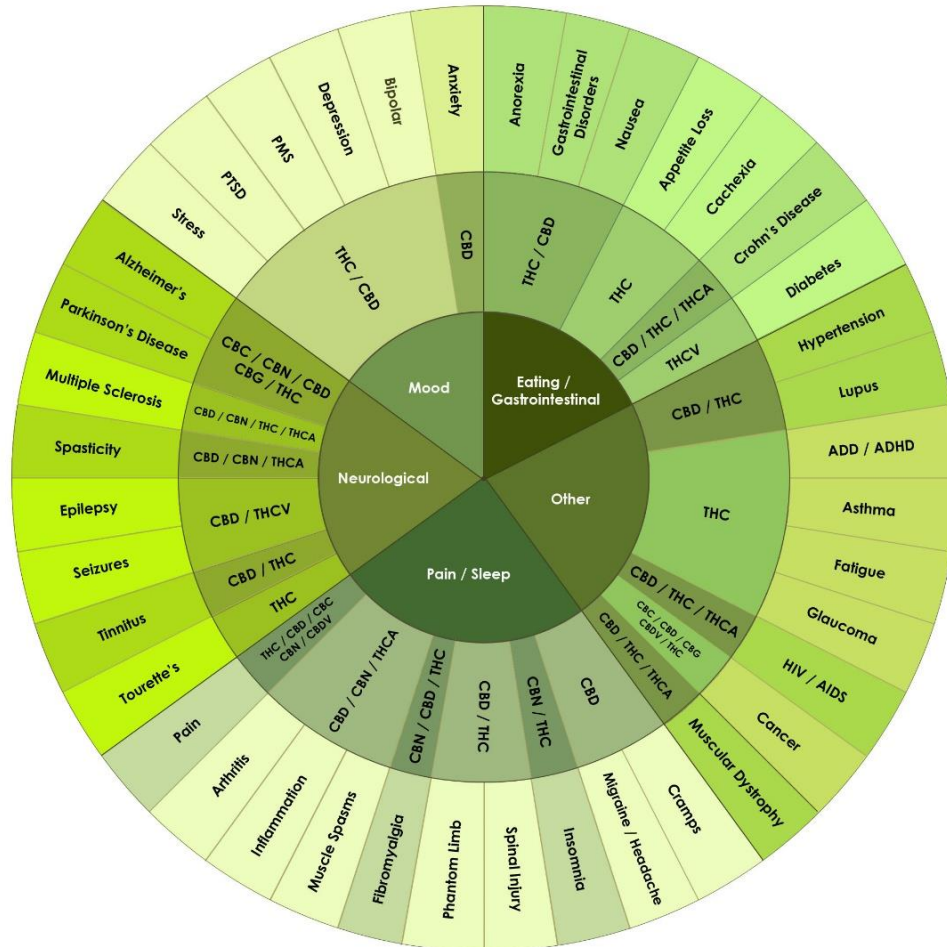

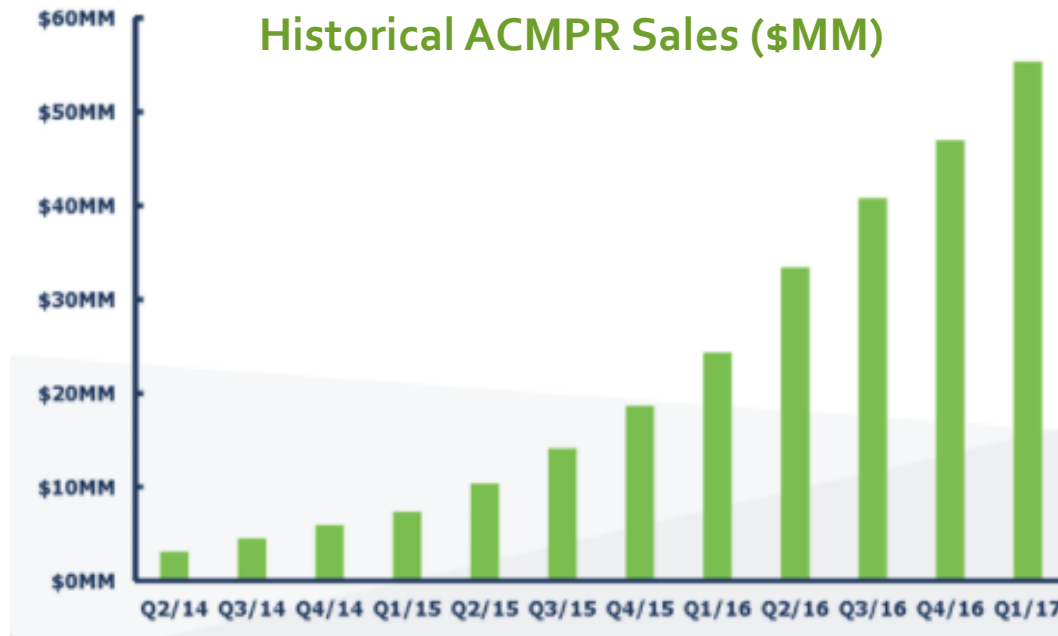

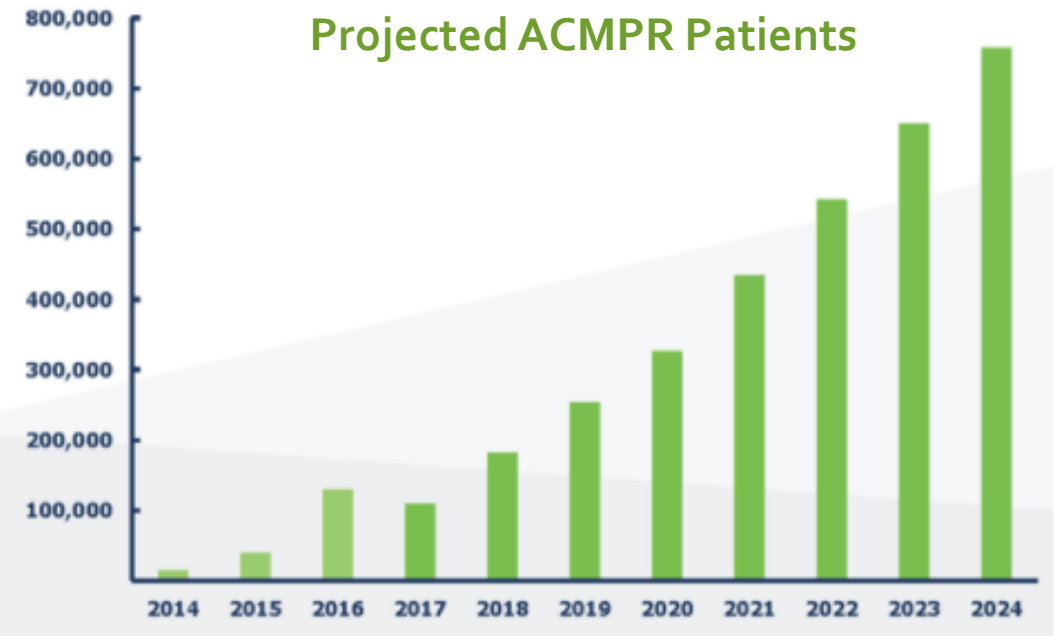

Industry Production Margins



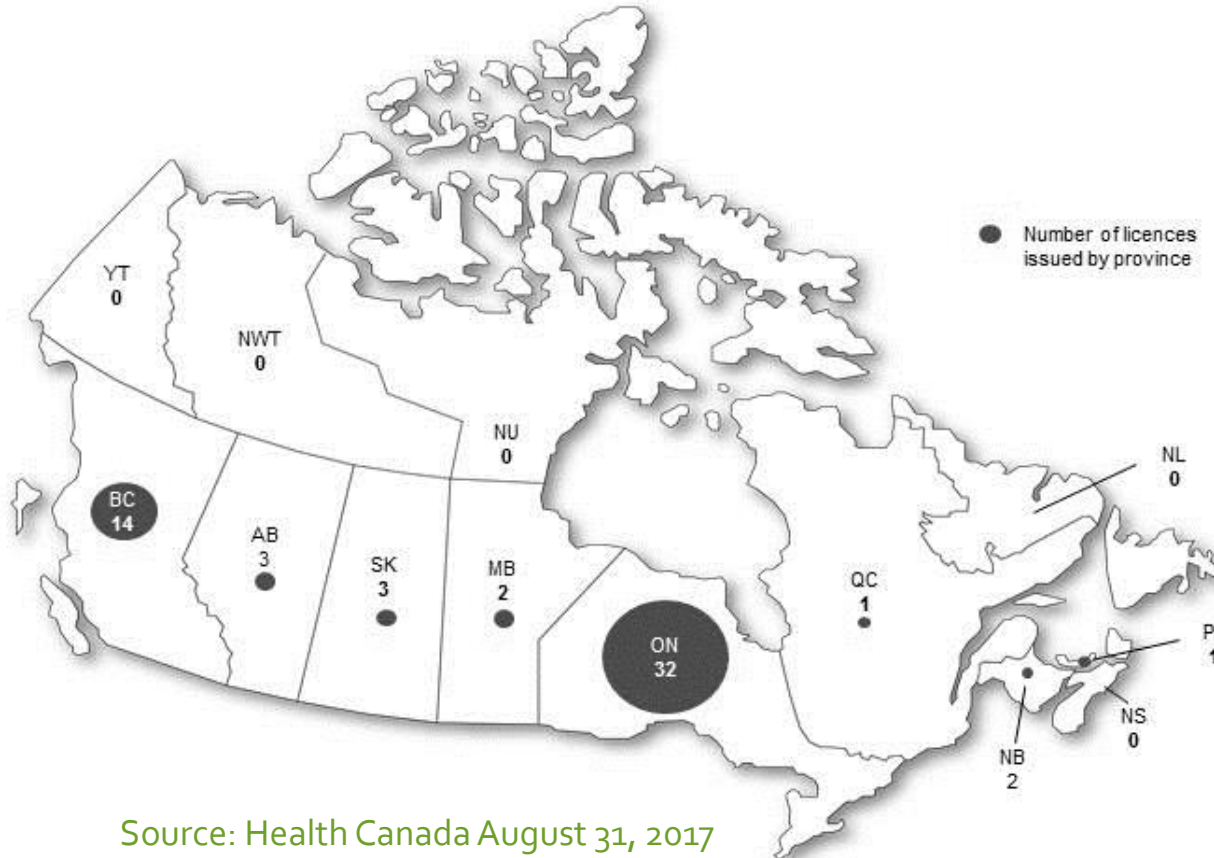

Cannabis Activity on Proposed Site

- Curativa Cannabis, a division of EnviroSAFE Chemicals Canada, will provide commercial-scale cannabis with an unmatched level of environmental control, to develop, refine, and repeat specific growth conditions.
- To produce specific plant properties in every harvest propagation plants from clone and seeds, to cultivate numerous strains. It is our intent to establish a healthy root zone and sustain vegetative growth with adequate humidity, horizontal airflow, watering and constant temperature control.
- During the final growth stage, high light intensities and longer daylight cycles to develop desired plant mass and root base prior to blooming.
- Next stage is drying, curing, high ventilation, low humidity and slightly lower temperatures are required during drying stage.
- Streamlining workflow, controlled irrigation, automated nutrient supply, and space efficient benching.
- Curativa Cannabis will dry and process all cannabis flowers into labeled/inventoried vacuum sealed bags before delivery to compassion centers.

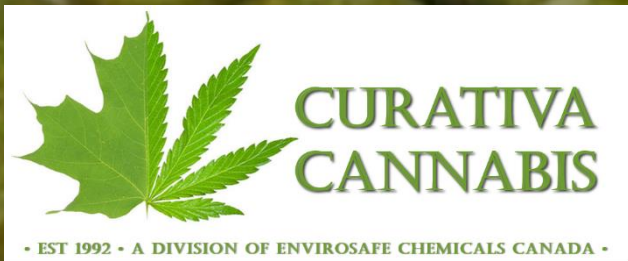
Regulatory, Tracking & Reporting

Curativa Cannabis will adhere to strict regulations to ensure compliance among citizens, producers and law enforcement. There will be no room for error when making critical business decisions around data and regulatory compliance. We will take proper measures to ensure tracking every aspect of the operation for mandated and frequent compliance reporting and inspection. Tracking marijuana and marijuana derived products from seed all the way to patient delivery.

We will implement the **Ample Organics Resource Planning (ERP) Seed-to-Sale system**, which utilizes **Zebra Hardware** for a complete, end-to-end solution to enable easier compliance with the Health Canada Regulations. The end-to-end solution encompasses inventory control and traceability, customer relationship management, logistics, electronic payment processing and secure E-Commerce. Zebra barcodes are the starting point for the plant-to-patient marijuana journey. Each plant receives its own barcode for identification through the propagation, cultivation and harvesting process. Once the plant is harvested, the barcode follows the plant material through the entire facility as it is trimmed, dried, packaged and lab tested. A complete detailed record and history of every single gram in real-time.

The system will quickly generate all inventory tags and barcodes to scan contextually and create efficiencies for employees when a patient order comes in through customer service or online. The computers help employees find, pick, label and pack each order to make sure it's all ties together. It works full-circle on everything entered and it is extremely accurate.

All data is collected and stored in real-time within the Ample Organics System. This is essential since **Health Canada** performs such frequent inspections. Overall efficiency will be good as the call centre puts an order in or someone submits an order online, the orders are processed immediately easy for staff to locate and fill orders. Staff sees inventory levels right away, which helps with production planning. This will achieve data integrity, improved work efficiency and ensure regulatory compliance. Tracking inventory in real-time. We have real-time data regarding our inventory including where our product is and the status of all parts of the inventory in real-time. Ample Organics Software, coupled with the hardware will create a system of checks and balances through the entire marijuana journey.

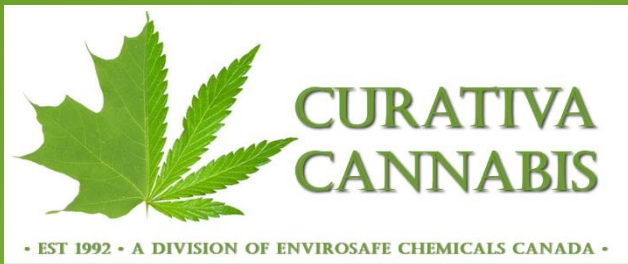

“There is a great demand for it,” he said. “They can’t produce it fast enough. There is a need for other producers – like what we are trying to do.”

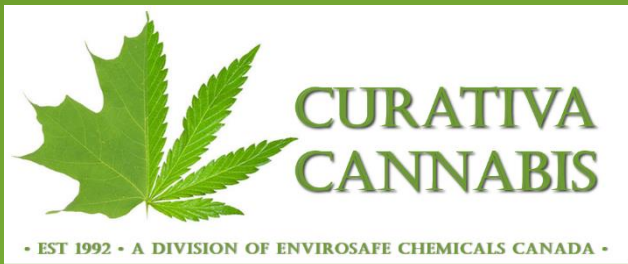
